### A RESOLUTION ENACTED BY THE VILLAGE OF NEW LEXINGTON GIVING CONSENT TO THE DIRECTOR OF TRANSPORTATION TO COMPLETE BRIDGE INSPECTION PROGRAM SERVICES AND DECLARING AN EMERGENCY

#### PRELIMINARY LEGISLATION

The following is a resolution enacted by the Village of New Lexington of Perry County, Ohio, hereinafter referred to as the Local Public Agency (LPA).

#### **SECTION I - Project Description**

WHEREAS, the Village of New Lexington (LPA) has determined the need for the described project:

Bridge Inspection Program Services, including, but not limited to bridge load rating calculations, scour assessments, bridge inspections, and fracture critical plan development.

NOW THEREFORE, be it ordained by the Village of New Lexington of Perry County, Ohio.

#### **SECTION II - Consent Statement**

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

#### **SECTION III - Cooperation Statement**

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

The State shall assume and bear 100% of all of the cost for Bridge Inspection Program Services requested by the City and agreed to by the State. Eligible Bridge Inspection Services are described in the Consultant's Scope of Services Task Order Contract (Exhibit A).

The LPA agrees to pay 100% of the cost of those features which are not included in Exhibit A.

**SECTION IV - Utilities and Right-of-Way Statement**

The LPA agrees that all right-of-way required for the described project will be made available in accordance with current State and Federal regulations.

**SECTION V Authority to Sign**

I, Scott A. Bryant, Administrative Director of said Village of New Lexington is hereby empowered on behalf of the Village of New Lexington to enter into contracts with the Director of Transportation which is necessary to complete the above described project.




